
[Additional Information] Regarding Refund of Payment

If any of the following are not completed by the specified deadlines: ① Online registration, ② Payment of admission fees (1st and 2nd), or ③ Submission of admission documents, it will be deemed that you have no intention to enroll, and there is no need to inform us of your withdrawal.

However, if you wish to withdraw from APU after paying the second installment of admission fees [First semester tuition fees A & B, various membership fees, and (if you opted for AP House) dormitory prepayment], refunds for these fees (excluding admission fee and AP House dormitory prepayment) will be issued if a formal request is submitted by March 31, 2025 (for April admission) or by September 20, 2025 (for September admission), in accordance with university procedures.



Fill out the "Application for Refund of Admissions Fees and AP House Entrance Fee" (form provided by the university) and send it by express or registered mail.

* Please note that the Moving-in Fee will not be refunded.
